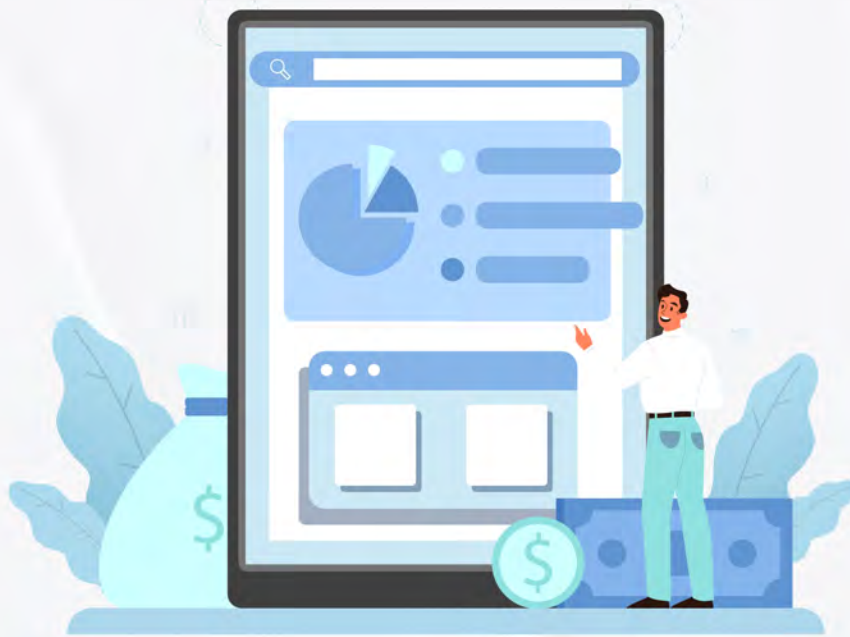

Mohammad Pizuar Hossain, a distinguished alumnus and faculty member of the Department of Law at East West University, has been awarded two distinct fully funded scholarships to pursue his PhD in Law from two universities in the UK and Australia. He has been awarded the prestigious Edinburgh Doctoral College Scholarship (Law) for a 4-year PhD program in law at the University of Edinburgh in Scotland, the UK. He has also received both the Monash Graduate Scholarship (MGS) and the Monash International Tuition Scholarship (MITS) for a 4-year PhD program in Law at Monash University in Melbourne, Australia.

Ms. Nabila Farhin & Ms. Nadia Rahaman, Senior Lecturer, Department of Law, East West University received a research grant from University of South Carolina, USA for a research project on “Empowering Workers for Justice: Legal Framework Review”. This eight-month project ended in February 2024. The project ran in collaboration with Bangladesh Legal Aid and Services Trust (BLAST). The project focused on ensuring labor rights for the workers of different sectors, advocating necessary legal reforms to strengthen protection for workers, and empower workers by raising awareness.

Professor Shams Rahman from East West University and Dr Aswini Yadlapalli from RMIT University, Australia, have successfully completed supervising the PhD thesis of Alaa Aljedaani in April 2024. Dr. Aljedaani was a PhD student at RMIT University, Melbourne, Australia.

Dr Aljedaani developed a theoretical model that conceptualizes the digitalization of warehouses in Saudi Arabia. The results show that actions such as structuring, bundling, and leveraging are crucial to managing resources for warehouse digitalization. From a practical perspective, this study will guide managers in developing a step-by-step procedure for the digital transformation of their warehouses.

She will conduct her postdoctoral research as a Fulbright Visiting Scholar on the topic entitled 'Investigation of novel fungal-derived secondary metabolites as potential therapies for vascular dysfunction, atherosclerosis and high blood pressure' in the Department of Pharmaceutical Sciences, College of Pharmacy, Mercer University, Georgia. During the nine-month grant period of this esteemed Postdoctoral Fellowship starting from September 2024, Dr. Hoque will examine the role of selected fungal-derived molecules in inhibiting blood vessel wall inflammation and high blood pressure using a combination of different in vitro, in vivo and biomolecular techniques.

Ali Mashraf, Lecturer, Department of Law, received the 'Professor Mahfuza Khanam-Barrister Shafique Ahmed Trust Fund Scholarship' from the University of Dhaka in recognition of his academic achievement for scoring the top CGPA among male students of the 2015-16 session of the Department of Law, University of Dhaka.

Monisha Biswas, Senior Lecturer, Department of English, successfully completed an OPEN (Online Professional English Network) certificate course on Teaching and Developing Academic Writing with 99.21% marks (377 out of 380 marks).
